



Pine Tree Legal Assistance – Bangor Office Maine VISTA Project Position Description

The Maine VISTA Project offers members a variety of opportunities to serve that include developing or expanding programs related to Veterans & Military Families, Education, and volunteer program development. This 26-member project is sponsored by the Maine Commission for Community Service (MCCS). MCCS builds capacity and sustainability in Maine's volunteer and service communities. Funding for the Maine VISTA Project is provided by the Corporation for National and Community Service (CNCS).

Pine Tree Legal Assistance is a nonprofit corporation with 501(c)(3) status established in 1966 by private attorneys in Maine to promote access to justice by providing high quality free legal assistance responsive to the immediate needs of individual low-income clients and to address the long-range barriers to justice affecting low-income people in Maine. The program has always included low-income veterans and service members in its client population and, starting in 2009, has taken a national leadership role in the development of www.statesidelegal.org as a clearinghouse website for military and veteran households with legal needs.

This VISTA member will become familiar with the legal services provided by Pine Tree and other legal aid providers in Maine, as well as the information and self-help tools provided on www.statesidelegal.org and www.ptla.org. He/she will use this information in updating/maintaining legal resources and self-help tools on the program's various websites. The VISTA member will learn how to undertake elementary legal research and how to develop original legal information resources written at a high school reading level and in plain English. All workproduct will be reviewed by Pine Tree staff and website advisors before it is published on the website. The VISTA will also be introduced to some basic concepts of technical web development in order to assist staff in updating online resources (which are produced in an Open Source Drupal CMS). The VISTA will also be responsible for developing a Facebook page to accompany www.statesidelegal.org, and working with staff to post appropriate content on the Facebook site. Finally, the VISTA will be responsible for participating in the statewide "Standdown" resource fair for homeless veterans in order to present information on legal services, and will participate in other networking and outreach events in northern and eastern Maine with members of the military or veteran community.

Qualifications:

- Self motivated with a high degree of flexibility.
- Clear, concise oral and written communication.
- Excellent organizational skills.
- Strong computer skills– including experience with website editing and social media tools.

- Bachelor's degree or equivalent is required.
- Previous experience in the military or an understanding of the military/veteran experience is preferred.
- Previous legal training/experience is helpful.
- Energetic commitment to justice for low-income individuals.
- Valid driver's license and access to reliable transportation.

Essential Functions:

Ability to:

- Relate to diverse people and to work effectively with colleagues.
- Define problems, collect data, establish facts, and draw valid conclusions.
- Speak clearly and effectively to groups (large & small).
- Conduct basic research and write clearly.
- Use computer software such as Microsoft Office and navigate the internet.

Benefits and Terms:

All AmeriCorps*VISTA members receive a living allowance (\$936/mo), health benefit, and (upon successful completion of service term) a \$5,550 educational award or \$1,500 cash stipend. Additional benefits available to eligible members: relocation allowance, child care credits, student loans may qualify for deferment, and term life-insurance. The hosting organization will reimburse mileage expenses associated with project travel. (Please note: VISTA members commit to full-time service for one year and other terms.
